To help preserve the world-class performance and appearance of your vehicle, the Porsche Protection Plan offers a suite of optional protection products to help keep your Porsche vehicle looking its best and performing even better. Drive with confidence knowing you have coverage that will help your Porsche vehicle maintain its appearance, performance, and value for years to come.

Coverage terms are available for up to seven (7) years, and monthly payment options are available if you include the plan or product price in your auto financing. Speak with your authorized Porsche dealer regarding the best way to manage the ongoing care of your Porsche vehicle.

Multi-Coverage product options include various combinations of the following:

- Premier Tire & Wheel Protection
- Dent Protection
- Windshield Protection¹
- Key Protection

Premier Tire & Wheel Protection

Proactive protection.

Tires and wheels are the only parts of your Porsche vehicle that touch the road. Unfortunately, they also come into contact with road hazards such as glass, nails, potholes, and debris. We offer a way to protect them from these hazards. Keep your tires in top shape with Premier Tire & Wheel Protection so you can stay on the road.

Premier Tire & Wheel Protection coverage includes:

- Replacement of a tire if structurally damaged to the extent it fails to hold air due to a covered road hazard, including glass, potholes, debris, or nails (includes tires with run-flat technology); tires are never plugged or patched.
- Replacement of a wheel if road hazard damage prevents the wheel from sealing to the tire or maintaining the tire manufacturer's air pressure specifications.

- Replacement using OEM or OEM-approved tires and parts during the product agreement term, if they meet the manufacturer's size specifications.
- Coverage of approved costs associated with the replacement of the tires and/or wheels if structurally damaged, including labor charges, mounting, balancing, valve stems, and tire disposal, less the applicable deductible amount.¹
- Towing expenses reimbursed up to \$250 per occurrence in the event of covered road hazard damage.

- Replaced parts will be covered for the remainder of the product agreement term if they meet the manufacturer's size specifications.
- Transferable for a fee if you sell your vehicle to a private party or if another party assumes the lease agreement.²
- Cancelable at any time; after 30 days, subject to a fee.³

Cosmetic Repair includes:

- Repairs of cosmetic wheel damage such as nicks and scrapes.
- Repairs are limited to sanding, painting, or refinishing the wheel without the need to apply additional material or bend/straighten the wheel.⁴
- Cosmetic wheel repairs are limited to a total of eight (8) individual wheel repairs during the product agreement term.
- No deductible.

Additional benefits:

- No limit to the number of structural damage claims.
- No mileage limitations.
- Nationwide service is available at all participating, authorized Porsche dealers or other authorized licensed repair facilities.

Coverage exclusions may apply:⁵

- Damage to tires with less than 3/32" tread depth at the lowest point on the tire at the time of damage.
- Replacement or re-manufacturing of wheels due to cosmetic damage.
- Cosmetic damage to tires.
- Damage caused by vandalism, theft, or driving with low or no tire pressure.
- Repairs made without prior authorization from the Porsche Protection Plan Administrator.
- Damage caused by road conditions (such as uneven lanes or metal plates) found in construction zones or construction sites.
- Failures from normal wear and tear, improper wear, or dry rot.

Dent Protection

Unightly dents and dings can greatly reduce the resale or trade-in value of your vehicle. Maintaining the value and beauty of your vehicle is easy with Dent Protection, a convenient way to remove door dings and minor dents without repainting.

Dent Protection includes:

- Removal of door dings and minor dents from everyday use, without harming your vehicle's factory finish.
- Repairs to dents and dings no larger than four (4) inches in diameter within an accessible area located on a body panel of your vehicle.
- Hail damage covered up to the lesser of your primary insurance deductible (if a claim was filed) or \$1,000 per incident.
- Transferable coverage for a fee if you sell your vehicle to a private party or if another party assumes the lease agreement.¹
- Cancelable at any time; after 30 days, subject to a fee.²

Additional benefits:

- Repairs can be performed conveniently at any participating, authorized Porsche dealer, your home, or your work.
- No limit on occurrences or claim benefits.
- No limit on the number of service calls.
- No mileage limitations.
- No deductible.

Coverage exclusions may apply.³

- Dents or dings that are larger than four (4) inches in diameter.
- Dents or dings that cannot be repaired by the paintless dent repair process.
- Paintless dent repairs exceeding \$1,000 for hail damage⁴
- Dents or dings not located within an accessible area.
- Damage caused by vandalism.
- Repairs that will affect or damage the vehicle's paint or finish.
- Vehicles without steel or aluminum body panels.

Windshield Protection

Windshield Protection includes:

- Repairs to chips and cracks in the front windshield caused by propelled rocks and other road hazard debris while driving on public roads, streets, and highways.
- Unlimited repairs and one (1) replacement of the front windshield during the product agreement term.²
- Charges for manufacturer-required vehicle system calibration procedures as a result of windshield replacement, up to \$500 total.
- Transferable for a fee if you sell your vehicle to a private party or if another party assumes the lease agreement.³
- Cancelable at any time; after 30 days, subject to a fee.

Additional benefits:

- Repairs can be performed conveniently at any participating, authorized Porsche dealer, your home, or your work.
- No mileage limitations.
- No deductible.

Coverage exclusions may apply:²

- Damage to areas other than the front windshield.
- Stress cracks.
- Damage caused by hail, vandalism, or neglect.
- Repairs that will result in an obstruction of the driver's line of sight.
- More than one (1) replacement of the front windshield.
- Wheel alignments.⁵
- Charges for manufacturer-required vehicle system calibration procedures as a result of windshield replacement exceeding \$500.

Key Protection

Your Porsche vehicle key has advanced technology that makes it costly to replace. Key Protection provides protection, security, and peace of mind whether your keys are lost, damaged, or stolen.¹

Key Protection includes:

- Replacement of the vehicle key/remote (up to \$800 per occurrence) if your Porsche vehicle keys are lost, damaged, or stolen.¹
- Lockout assistance to unlock the covered vehicle if your vehicle keys are lost, damaged, or locked inside your car (up to \$100 per occurrence).
- Towing assistance to the nearest registered service facility or other facility of your choice (up to \$250 per occurrence).
- Taxi/rental vehicle/public transportation reimbursement (up to \$75 per occurrence).

- Transferable for a fee if you sell your vehicle to a private party or if another party assumes the lease agreement.²
- Cancelable at any time; after 30 days, subject to a fee.³

Additional benefits:⁴

- 24-hour home lockout assistance to unlock your home; includes locksmith reimbursement (up to \$100 per occurrence) and house key replacement of up to three (3) house keys (up to \$75 per key replacement).
- Replacement benefit for additional non-programmable keys on the key ring, such as home, RV/trailer keys, and office keys (up to \$250 per occurrence).
- Emergency message relay for up to three (3) emergency contacts.
- No mileage limitations.
- No deductible.
